Bill update

The 2021 Legislative Assembly Adjourned Sine Die June 26th, 2021. All bills had to pass by June 26th. If they did not they died.

SB-191 - Died**SB-401 - Died****HB-2002 - Died**

HB-2172 - Passed - Expands eligibility for earned reduction in supervision to include persons on any type of supervision who are not serving sentence for disqualifying crime - This bill was amended to exclude all M11 ORS#'s

SB-819 - Passed - Senate Bill 819 recently passed in the Oregon Legislature and was signed by Governor Brown on 6/23/2021. The law will become effective on January 1, 2022.

SB 819 establishes a procedure for people convicted of and sentenced for felony offenses to petition their sentencing court for reconsideration of their conviction/s or sentence/s if the original sentence no longer advances "the interests of justice." The felony offense cannot be aggravated murder, but does include all other M11 convictions (GREAT NEWS!)

The petition must be jointly submitted by the convicted person and the district attorney of the county in which the person was sentenced. The petition must include each of the convictions to be reconsidered, and the terms of the agreement between the convicted person and district attorney; the terms can include dismissal of the charges, vacating previous convictions, a plea to a new alternative offense, resentencing for the original conviction or sentencing for the new offense. The sentencing court must hold a hearing once it receives a petition. If the court grants the petition, it has to proceed in accordance with the terms of the agreement in the petition. NOTE: They cannot increase sentencing.

Continue on Bill update

SB-819 continued

SB 819 requires the district attorney to use reasonable efforts to inform the victim(s) of each associated conviction and includes the victim(s) receiving a copy of the petition, the ability to provide input during the process, and the opportunity during the hearing to make a statement.

In the coming months, district attorneys across the state will be deciding their policies relating to SB 819, possibly creating forms and materials about how their offices will go about handling requests for petitions.

REMINDER - this bill goes into effect January 2022. We will keep you up to date via our newsletter on the correct procedure in the next few months. Please DO NOT send requests asking if you qualify or how you can apply. Information and instructions will be provided in our newsletters.

Visitation

The pilots for visitation resumed last month, June. OSP (June 4th), CRCI (June 6th), OSCI (June 14th), CCCF (June 21st). Now that Oregon is open, visitation is open. **You have to schedule your visit.** You can schedule your visit by going to ICS Corrections website, www.icsolutions.com, complete the same way as a video visitation, click on "on site visit", pick your date, day and time.

General Information: All visits will be in person non-contact and social distancing will be enforced. Some facilities is one visit per week others are two visits per week , two visitors at a time, no food, drinks, photo opps, no toys, games, cards, or magazines will be accessible, nor the play area for children.
