SB 191 Reduction in Sentence

Great news everyone, we now have a Bill number...... SB 191
Now is the time to take action. We need everyone to step forward and write your Senator(s). Let them know how earning good time (Sentence Reduction) will change your life, what it means to you and your loved ones and how it will affect you and your loved ones. Let them know it will encourage and support better moral, not only to AIC's but those working within the prisons. Make sure you ask them to vote yes. Keep your letters short (one page), to the point and simple. Remember they will be getting lots of letters, emails and phone calls from us, so let's get their attention and let them know M11, earning Good Time (Sentence Reduction) needs to change. Plan to write several Senators besides your Senator, write every week. Lets flood them with letters and non AIC's (loved ones of AIC's), all ages, can write letters, send emails and make calls. All Senator information is listed on page 2 of this newsletter. I sent a spreadsheet with emails and phone numbers to all loved ones on my email list and posted on FB.

AIC's please ask your loved one to send you a copy of the bill. In order for our bill to pass through the Senate and House, we need 2/3 vote. There are 30 Senators, we need 20 with a YES vote

After it passes on the Senate side, it will go to the Representative side. There are 60 Representatives and we will need 40 YES votes. I will send those names and address out to AIC's when we need their vote.

SB 191 TDNFTC, Our bill supports Sentence Reduction (earning and applying Good Time to M11 convictions)

SB 401 Senator Prozanski's bill - Supports Presumptive sentences. His Bill is requesting the decision to be put back in the judge's hands when someone is being convicted of M11.

Rumor has it that reduction in sentencing with our bill will be from 20% to 50% - FALSE!! You can check your %. Each AIC might be a little different depending on sentence. Every six months you are given a "FACE Sheet". Toward the top you will see " Earned Time Computation" with your % of what you have earned so far. Now it says "not eligible". With our bill the "not eligible" will change for those that qualify.
