I know this is a waiting game. The power is in the legislator. All we can do from here

SB 191 Reduction in Sentence

Hopefully everyone has heard - we have a Bill number..... SB191. Our bill is asking for those sentenced under Measure 11 to be allowed to earn good time. We are asking for it to be retroactive.

There are three bills in Legislator regarding Measure 11.

I was informed on Friday 1/5/21 that the Judiciary committee's are forming a "group" to review and possible bring these bills together to get better action. I (Patty) have been asked to join this group to represent TDNFTC. Will let you know the outcome.

TDNFTC - SB191 - still in Senate committee

Safety & Justice (PSJ) - HB2002 - Public Hearing scheduled 2/16/2021 (postponed due to power outage. Public Hearing scheduled 2/25/2021

Senator Prozanski's bill - SB401 - still in Senate committee

RUMORS..... no bill has gone on to Governor's desk. All bills are still in Senate or House for vote.

Time Frame:

- Committees by end of February
- Senate (or House for HB bill) to approve by mid/end of March
- Representatives (or Senate for HB bill) to approve by mid/end of April
- Governor to approve by end of June

In order for our bill to pass through the Senate and House, we need 2/3 vote from each side. There are 30 Senators, we need 20 YES votes. After it passes on the Senate side, it will go to the Representative side (vice versa for the HB bill). There are 60 Representatives and we will need 40 YES votes.

We need all of Legislator to understand why incentives / earning good time / earning sentence reduction is important. Prison is a place to learn a lesson for their mistake. It makes no sense at all if an AIC doesn't respect anyone, doesn't hold a job, constantly in fights, spends the majority of their time in the hole, gets out at the end of their sentence the same as the person that helps & respects others, holds a job, and hasn't been to the hole. AIC's needs a reason to better themselves, stay out of trouble. An incentive would help to work toward that goal. Earning Sentence Reduction would boost morale and would make the work environment for all a better place. Working to earn their way out of prison would make Oregon a safer place upon AIC's release.

Hopefully you are doing your part and writing, emailing and/or calling Senators asking for their YES vote on SB191.

Emailing & mailing

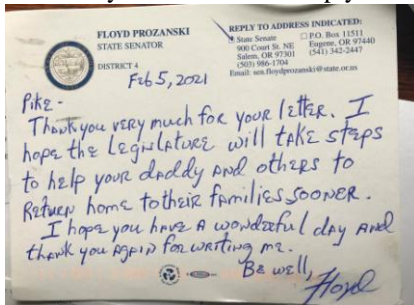
