Greetings from the Co-Founder of TDNFTC

I want to personally thank everyone that submitted testimonies for SB191. We received over 400 and please know that although our Bill did not pass your testimonies will make a difference sooner or later, so please keep those testimonies coming. Let's not give up hope because change is coming! Our Bill died because one Legislator made the decision that it would not move forward for vote and I will say that it's disappointing that one Legislator can make that decision. I guess that's life and that's how our congress is ran, but that is also why we are here to keep advocating for our rights. I did let that one vote know it wasn't fair that it didn't go on to a 3/4 vote per Measure 10. Now that SB191 is dead, not all is lost. SB401, if it passes, will be a step forward. We will be advocating to get it passed. It's not retroactive but hopefully it will in some way or another benefit some of you.

Bills update

SB191 unfortunately DIED before going to committee vote.

Requesting Sentence Reduction be applied and have it retroactive

SB401 Passed Senate Committee and referred to Rules. This is a step before the Senate floor votes and where amendments can be made. Not all bills make it to the floor for vote. Fingers Crossed!! No dates have been assigned as of yet. Converts mandatory minimum sentences for specified felonies other than murder to presumptive sentences.

HB2002 all Measure 11 (first section) has been REMOVED from this bill and sent to be combined with SB401.

The remaining parts states RESTORATIVE JUSTICE (grants), ARRESTS AND STOPS (cannot pull anyone over without cause, and must provide name and badge #), JAIL ADMISSION FOR ILL PERSONS (cannot arrest due to any mental medical issues), COMMUNITY CORRECTIONS (where and when Parole and Probation Officers can visit), EXPANSION OF EARNED REDUCTION IN SUPERVISION (make it more clear to the AIC if they are eligible and details in writing).

HB 2172 passed House Committee and referred to Judiciary, An amendment was approved that excluded all measure 11 ORS's. Public Hearing was held May 6.

Converts mandatory minimum sentences for specified felonies other than murder to presumptive sentences.
