# May Newsletter mishap

There was a mishap in mailing our May Newsletter. There was a flaw with our printing service last month and the SID #'s did not get put on the envelopes. Some newsletters did make it through to AIC's but most didn't. We did get all of OSCI's newsletters back and confirmed most did not received them at EOCI. We are including our May Newsletter to all AIC's on our list with our June Newsletter. I do apologies for the delay in receiving our May newsletter and hopefully this will not happen again.

#### Bill update

**SB-401** Converts mandatory minimum sentences for specified felonies other than murder to presumptive sentences. This bill is still alive. Senator Prozanski has amended this bill to scrap M11 sentences for second-degree assault and robbery, no matter what.

From an article in OPB 7/3/21: Rep Janelle Bynum (D), who chairs the House Judiciary Committee said "People feel like the time should fit the crime". Prozanski's decision to narrow his proposal a reality in Oregon: Many Republican lawmakers and many district attorneys oppose any changes to Measure 11's sentencing framework. Since it would require a two-thirds vote in both chambers of the state Legislature to alter the measure, SB 401 had no chance in its original form. Even if he gathers support from Republicans, and with a handful of district attorneys on board, the biggest obstacle Prozanski faces is time. The legislature must adjourn by June 27. "It's not over 'til it's over," Bynum said. "The Legislature is an interesting animal, and I continue to be amazed at what it can and won't do."

**SB-819** was just brought to our attention. This bill passed Senate and House floor and was signed by the Senate president today 6/14/2021.

Establishes procedure by which district attorney and incarcerated person may jointly petition sentencing court for reconsideration of conviction and sentence. Authorizes court to, upon granting petition, resentence person on original conviction, vacate previous judgment of conviction, accept plea to new offense and impose sentence on new offense. Directs district attorney to notify victim or survivor of victim of consideration hearing and process.

TDNFTC has requested a meeting with the sponsor of the bill to get better clarification. **HB-2172**, passes House 4/27/21, as of 6/14/21 on second reading on the Senate floor **HB-2002**, still with the House (Representatives) Ways & Means speaker
